TERMS & CONDITIONS

- Hudson Contract will also be referred to as Hudson and the promoter within these Terms & Conditions.
- The promotion is open only to residents over the age of 16 in the UK, and participants are subject to acceptance of these Terms & Conditions.
- By entering this promotion all participants will be deemed to have accepted and be bound by these Terms & Conditions. All entry instructions form part of these Terms & Conditions.
- The information you supply is collected by Hudson and use of the information will be subject to our privacy policy. By submitting your entry you consent to your personal data being used in this way.
- By entering the promotion all participants accept that they will have no claim against Hudson, whatsoever and agree to give Hudson a complete liability release from any and all legal liability in connection with the promotion.
- Hudson accepts no liability or responsibility for votes lost, delayed, misdirected, incomplete or undelivered, nor any

PROMOTION DETAILS

- The entry submission begins on Tuesday 12th June 2018 and closes on Sunday 8th July 2018.
- All entries must be submitted between these dates. Any entries received before or after this closing date will not be accepted.
- Incomplete entries, entries on behalf of another person and joint or syndicate entries will not be counted.
- Entries must fulfil the criteria laid out in the Terms and Conditions.
- Participants may only nominate one team.
- The promoter reserves the right to refuse any vote that is believed to be in breach of the Terms and Conditions.
- Entries will not be considered as part of this promotion if, at the sole discretion of Hudson, they contain language or images that are in any way threatening, abusive, offensive, defamatory, invasive of another's privacy, in breach of confidence, embarrassing to any person or likely to deceive any person, hateful, bullying, blasphemous, obscene, vulgar, pornographic, threatening, or racist, sexist, ethnically discriminatory or otherwise objectionable or which constitutes or encourages conduct that would be considered a criminal offence or otherwise contrary to and violate any law.

- Only the judges and Hudson staff will see your nominations. Judges review and score entries remotely, to nominate their desired shortlist.
- In all cases Hudson's decision is final and no correspondence about this decision will be entered into.
- To ensure fairness and the integrity of the promotion to all participants, the promoter will not enter into discussions regarding the running of this promotion via social media or through direct contact.
- Any participant posting or seen to be posting comments, images to Hudson's website, social media, or elsewhere during
